# **Amateur Radio License Exams**

## **Exams are free.....No Test Fees will be collected!!!**

The Dial Radio Club & Butler County Amateur Radio Association will offer amateur radio operator's license examinations, at 6:00 pm, on Wednesday, April 29, 2026, at St. John XXIII School, 3806 Manchester Road, Middletown, OH 45042

Applicants must furnish if any, original of any certificates of successful completion of examination (CSCE) they may hold and positive (photo) identification.

Please note, before accessing CORES, users must establish an FCC username account in the FCC User Registration System by providing a valid e-mail address and creating a password. Go <https://www.fcc.gov/wireless/support/knowledge-base/universal-licensing-system-uls-resources/getting-fcc-registration>

If you are applying for your first license, please go to <https://www.fcc.gov/wireless/support/knowledge-base/universal-licensing-system-uls-resources/getting-fcc-registration> a FRN. This website is self-explanatory and the FRN registration is free.

**Pre-registration is STRONGLY Suggested, walk ins are welcome go to <https://HamStudy.org/sessions/dial> at least 24 hours prior to the exam, it is quick & easy.**

**The FCC fee for new licenses is \$35.00, upgrades are free**
